### 67/20 Apologies for Absence

### 70/20 Minutes of Meeting held on 14 December 2020

**Resolved** that the minutes of the meeting held on the 14 December 2020 be agreed & signed by the Chairman as a correct record.

### **71/20 Correspondence**

**Resolved** that the schedule of correspondence be received & noted & that:

- 1) It be agreed that two bus shelters were required at Eagle Gill, Flimby, & that permission be sought for permission to install suitable shelters at suitable sites from the land owners & Cumbria County Council, as appropriate.
- 2) No comments be offered to Allerdale Borough Council concerning its 2021/22 Budget Consultation.
- 3) Further to Cumbria County Council's Cumbrian Laptop Appeal:
  - a) The Town Council agree an initial budget of £4,000 towards the provision of tablets & laptops for Maryport Schools, based on the schools' identified needs, for assistance for young people in need their home learning following schools' closure due to the Covid-19 pandemic.
  - b) A virement of £4,000 be made from the Festivals Promotion budget to support the scheme.

### **76/20 Allerdale Area Office Front Desk Accessibility**

**Resolved** that, given the Town Council's concerns at proposals by Allerdale Borough Council to change accessibility arrangements for members of the public to its Maryport Office to an appointment-only system, Allerdale be advised of the Town Council's concerns at the potential impact of the proposals on users, particularly members of the community who struggled with modern technology, & that the Town Council's preference was for a non-appointment-based system.

**Resolved** that, further to the lack of awareness of the scheme & the lack of interest in it shown by Maryport Schools, it be agreed not to support the scheme at this time.

**Resolved** that Allerdale Borough Council Planning & Building Control Manager be contacted to arrange for a site meeting, due to the dangerous state of the building, noting that it was understood that the building was the subject of a compulsory purchase order by Allerdale Borough Council some twenty years ago, as a result of which the owners were rehomed.
