## 17/14 Correspondence

**Resolved** that the schedule of correspondence be received & noted, & the following matters determined:

- That, further to the letter from Mrs H Byers of Elizabeth Street, Maryport, the Council contact Allerdale Borough Council to request that it utilise its housing legislation powers to address the problems at the property adjoining that of the correspondent.
- 2) That the Council support the concerns received from Ms L Wyatt, PR & Marketing Director of Maryport Maritime Museum, regarding the potential impact of the proposed introduction of street parking charges in Maryport, & that a copy of her letter be forwarded to Cumbria County Council.
- 3) That, noting the Police & Crime Commissioner's proposal to implement a county-wide, public space CCTV project, the Council support the provision of such security measures in Maryport.
- 4) That it be noted that Cumbria County Council was dealing with the Town Council's request for information concerning the proposed introduction of street parking charges as a freedom of information request.

### 18/14 Senhouse Street

**Resolved** that it be noted that the unsuitability of the road layout on Senhouse Street was discussed by Town Council representatives & Cumbria County Council representatives some twenty four months ago, when the Council's concerns were reported, & that:

- 1) The Chairman be authorised to raise objections at the Cumbria County Council Allerdale Area Committee meeting, due to be held on 17 July.
- 2) The potential problems caused by vehicles parking on street corners, ignoring double yellow line markings, be also raised at the above meeting.
- 3) The Council note the absence of a hand rail on the left hand upward side of the pavement, which causes difficulty for some users due to its steepness, & request that Allerdale Borough Council introduce one.

## 19/14 Cumbria County Council Street Parking Charges

In the absence of Councillor Ms D Charlton, who had requested consideration of matters in respect of Cumbria County Council's proposed introduction of street parking charges, an email from Councillor Charlton, received in support of her proposals, together with an earlier email setting out her proposals, were considered. It was noted that:

- The matter of Cumbria County Council street parking charges had been discussed at the meeting of the Planning & Economic Development Committee held on 2 June 2014.
- 2) The introduction of street parking charges was not legislation, as had been stated by Councillor Charlton.
- 3) Councillor Charlton was proposing consideration of an issue which had previously been discussed & agreed upon by the Planning & Economic Development Committee, (Minute 9/14 refers), & it was of concern that discussion of issues took place at the appropriate time & decisions were not sought to be influenced at a later stage.

4) Councillor K Little of Cumbria County Council had agreed to attend the meeting, but it was considered unnecessary in the absence of Councillor Charlton.

### Resolved that:

1) The Council not support the drafting of a joint declaration setting out the Council's objections to car parking, & that the Council's previously agreed action be adhered to, (Minute 9/14), noting that Councillors Mrs A Kendall & P Kendall would be attending the Cumbria County Council Allerdale Area Committee Meeting to be held on 17 July, where the Town Council's objections to the proposed introduction of street parking charges would be raised by them.
