56/21 Correspondence

Resolved that the schedule of correspondence be noted & received & that further to the request from Allerdale Borough Council Business Engagement Manager Toni Magean for proposals for schemes to be financed from the Allerdale administered: Welcome Back Fund, which were required to be for locations in & around the town centre which improved the environment for the public, the Council propose to arrange, subject to owner's agreement, the repainting of railings on Shipping Brow, around the harbour & on Market Steps, together with additional Christmas lighting in the town centre.

57/21 Proposed Planning Reforms

Further to correspondence received from Mark Jenkinson MP concerning the government's proposed planning reforms, which in the Council's view gave a presumption of development leading to residents not being permitted to comment on individual developments, the Council disagree with Mr Jenkinson's accusations of the Council being overtly political & respond accordingly, noting that:

- 1) The government has yet to formally respond to the consultation on its Planning for the Future White Paper, which contains the proposals to reduce community input into the planning system as detailed by Town and Country Planning Association.
- 2) There have been rumours in the media that the government may change course on this, although there has been no public confirmation of this.
- 3) Further to Minute 38(2), despite Mr Jenkinson's claim that the Council had not taken him up on his offer to discuss the reforms, it had in fact contacted him twice in January & March requesting a written report on his detailed views of the proposals & had not received a response.
