47/21 Apologies for Absence

Apologies for absence were received from Councillors G Hampson, P Mallyon, Ms C Tindall, Mrs J Wood & M Wood.

48/21 Declarations of Interest

A declaration of interest was received from Councillor W Pegram, Item 5(4), personal as a member of the Maryport Harbour & Marina Board.

49/21 Requests for Dispensation

None received.

50/21 Minutes of Meeting held on 6 September 2021

Resolved that the minutes of the meeting held on 6 September 2021 be agreed & signed by the Chairman as a correct record.

51/21 Correspondence

Resolved that the schedule of correspondence be received & noted & that:

- 1) A grant of £2,500 be awarded to the Cumbria County Council Parkplay Scheme, the application being treated as an exception from Grant Policy since the scheme was seen as of great benefit to the children in the community's health following the covid pandemic restrictions & its impact on mental health.
- 2) The Council's concerns be expressed at the apparent arrangements being operated by Allerdale Borough Council in ground maintenance in the Maryport

& Flimby areas, whereby it appeared that the contractor was failing to carry out maintenance in accordance with the requirements, the failure was not being identified by Allerdale, leading to a reliance on complaints from the Town Council & others for the identification of the shortfall, & that:

- a) The Council notify the relevant Allerdale Borough Council Portfolio Holder of its concerns.
 - b) A site meeting be sought with Allerdale Borough Council Parks & Open Spaces officer Julian Smith to clarify the responsibilities for & ownership of land in the Flimby area.
- 3) The Council notify Mark Jenkinson MP that it will give consideration to a bench 'above the marina', as requested by Mrs R Fisher of Ismay Wharf, when the provision of additional benches is next considered, subject to identification of the specific site, its ownership & appropriate safety concerns being addressed.
- 4) Further to Maryport Harbour & Marina Ltd General Manager Pauline Gorley's response to Council request for joint provision of sea litter facilities & Ground Maintenance arrangements:
- a) A meeting be sought with members of the Maryport Fishing Co-operative, Pauline Gorley & Councillors B Copeland, G Hampson & J Newton.
 - b) Further details be sought of the ownership of land at south pier, north pier, tongue pier & the quay at the bottom of Shipping Brow.
- 5) Further to correspondence from Mark Jenkinson MP concerning Christmas lights, the Council contact Mr G Miller of James Street, Maryport, to ascertain his detailed concerns & notify Mr Jenkinson of this.
- 6) A grant of £1,000 be awarded to the Great North Air Ambulance in respect of its operations in the area.
- 7) The Council not support a request for support from Mrs Dolly Daniels for the removal of a handrail at Market Steps, noting its importance as a safety measure.
- 8) A grant of £1,000 be awarded to Maryport Amateur Operatic & Drama Society for its production of 'Scrooge'.
- 9) A grant of £1,000 be awarded to Maryport Army Cadets towards its Duke of Edinburgh scheme operations.
