17/22 Minutes of Meeting held on 27 June 2022

Resolved that the minutes of the meeting held on 27 June 2022 be agreed & signed by the Chairman as a correct record.

18/22 Correspondence

Resolved that the schedule of correspondence be received & noted & that:

- 1) Further to a request from Allerdale Borough Council for the Town Council to consider meeting the cost of two pieces of play equipment at Flimby Play Area, (which Allerdale was the responsible authority for & had arranged removal of equipment due to damage & had not replaced it due to the 'amount of vandalism' the site was subjected to), & noting a report from Councillor P Kendall that he had been advised by Allerdale Parks & Open Spaces Officer Julian Smith in 2020 that the pieces would not be replaced, the Council request further information from Allerdale Borough Council officers & respective portfolio holder as follows:
 - a) Does Allerdale Borough Council have insurance provision to cover vandalism to its play equipment?

- b) Has Allerdale Borough Council provided resources in budget to replace the damaged equipment?
- c) Has Allerdale Borough Council been requested to seek funding from underspends in budget & reserves to meet the cost of the replacement equipment?
- 2) Further to a request via Mark Jenkinson MP from the Minister for Sport, Tourism, Heritage & Civil Society on 29 June for evidence on short-term letting, the Council's concerns at the need for an effective system of control of this market to protect the area from loss of housing accommodation for local residents to both licensed & unlicensed short term let property owners be noted. & that it:
 - a) Support the introduction of a Statutory National Landlord Register to ensure effective enforcement of legal requirements for such businesses as short-term lettings to protect members of the public from unregulated operators & 'rogue' landlords.
 - b) Ascertain whether Cumbria Association of Local Councils has or could collate information from Cumbrian authorities on the number of such properties in the area

Resolved that Allerdale Borough Council be advised that:
