92/22 Maryport Regeneration

Councillor P Kendall reported to members his concerns with projects undertaken by the former Allerdale Borough Council financed through the Future High Streets Fund. He was concerned in particular with the prospects for sustainable employment, the extent of consultants' fees & the lack of revenue funding for the proposed swimming pool at The Wave. He reported that he had submitted to Cumberland Council a deputation arguing the case on behalf of the Town Council for a swimming pool in Maryport, which would be considered by the Cumberland Council Executive Committee on 25 April, & that he would be speaking at the meeting in support of the deputation. He advised that the Town Council had not received the report on proposals for addressing damp problems at Maryport Town Hall, which the committee had agreed to request a copy of at the previous meeting.
