Representatives on Cumberland Council Maryport Regeneration New Town Board & sub-groups reported on progress made on various projects. In particular, it was reported that:

- A noise level assessment was required at The Carlton development, where work continued internally, however, the original business case had been withdrawn
- The clocks had been reinstalled at Christ Church, where work to the mezzanine had been completed & work to the walls was awaiting the final finish
- Planting was planned at the boardwalk, together with the development of a mural
- Work was being carried out to repair some of the promenade railings & specifications for the skate park had recently been reviewed
- The streetscape work on Senhouse Street was on schedule
- Two options of design of the Play Park would be shortly going out for consultation
- An agreement for the management of the Play Area & Splash Park was under development by the Aquarium on the Town Council's behalf
- A lease agreement for the land on which the Entertainment Area & the Play Area & Splash Park would be sited was under development
- A meeting of the Harbourside Group would take place the following week, with the development being dependent on the lease agreement being in place
- Following a shortfall in official information provided to the Town Council being requested, minutes of Board meetings & Sub Groups would be provided to the Town Council by Cumberland Council
- Nominations for Maryport Community Champion2024 were to be notified to Cumberland Council Programme Director Kevin Kerrigan
